

## Hullabaloo Community Quire COVID-19 Risk Assessment 24<sup>TH</sup> March 2021

Hullabaloo Community Quire understands how important it is to work safely and support our participants' health and wellbeing during the COVID-19 pandemic and not contribute to the spread of the virus.

Alongside our continuing Zoom rehearsal schedule, offered to the more vulnerable and risk averse members of our community, Hullabaloo wishes to establish some real-life rehearsals for a small number (30 or less) of healthy members of the choir who are not in vulnerable groups to meet and rehearse in line with all government guidelines.

Please see our risk assessment below for organising a choir rehearsal, which are in line with the appropriate government guidelines referenced below.

### **GOV.UK – Working safely during Coronavirus. Non-professionals operating under the performing arts guidance: singing or other performing arts activity**

This guidance is part of a five-stage roadmap to bringing the performing arts back safely.

#### Social contact

The evidence shows that it is safer for people to meet outdoors rather than indoors. And this is why from 29 March, when most schools start to break up for the Easter holidays, outdoor gatherings (including in private gardens) of either 6 people (the Rule of 6) or 2 households will also be allowed, making it easier for friends and families to meet outside.

#### **Stage 1: Rehearsal and training only (no audience).( from 8<sup>th</sup> March 2021)**

#### **Stage 2: Performances permitted for broadcast and recording purposes (no audience). ( from 29<sup>th</sup> March 2021)**

Stage 3: Performances permitted outdoors with an audience, pilots for indoor performances with a limited audience. Outdoor performances preferable, where possible.

Stage 4: Performances permitted indoors and outdoors, with limits on audience numbers indoors. Outdoor performances preferable, where possible.

Stage 5: Performances permitted indoors and outdoors, with larger indoor audiences. Outdoor performances preferable, where possible.

During the current national restrictions, performing arts venues can only continue to operate under stages 1 and 2 of the performing arts roadmap.

## **GOV.UK – Working safely during Coronavirus. Non-professionals operating under the performing arts guidance: singing or other performing arts activity**

COVID-secure community facilities are permitted to hold social groups, clubs and activities in groups are subject to wider rules around social mixing dependent on an area's COVID local alert level. This means that, in a COVID-19 secure venue or public outdoor place, there can be more than 6 people in total present from multiple households. In local COVID alert level: Medium areas, social interaction and shared activity must be limited to groups of 6. In local COVID alert level: High, and local COVID alert level: Very High areas, social interaction and shared activity must be limited to groups of the same household or support bubble.

Unless a legal exemption exists (e.g. gatherings are for work) than any sub-group of six in tier 1 or individual household group in tiers 2 & 3 must not “mingle” with any other such group. In practice, this means social distancing should be maintained between each of these groups at all times including when entering or leaving the building and during any breaks. Direction can continue to take place during the activity i.e. between a conductor and a group or reflection between actors and directors, but other physical and social interaction is prohibited.

### **From the Department for Digital, Culture, Media & Sport (DCMS) in consultation with representatives of the performing arts sector, Public Health England (PHE) and the Health and Safety Executive (HSE).**

Businesses and venues following COVID-19 Secure guidelines can host larger groups...provided they take reasonable steps to mitigate the risk of transmission, in line with COVID-19 Secure guidance and including completion of a risk assessment. Within this guidance there are no set limits on the numbers who can be involved in planned non-professional activity taking place outside and/or in a Covid-secure venue. This is in line with guidance on “gatherings in Covid-19 secure venues” in the meeting people from outside your home guidance. However, organisations must ensure an appropriate COVID-19 risk assessment is carried out and that the numbers of individuals involved are able to be socially distanced at all times.

Organisations and venues will want to minimise the risk as far as possible and this guidance sets out a number of mitigations that should be considered when doing so.

- **Government performing arts guidance (11 September 2020) From gov.uk**

Additional mitigations, such as extended social distancing, were previously required for singing, wind and brass given concerns that these were potentially higher risk activities. DCMS commissioned further scientific studies to be carried out to develop the scientific evidence on these activities, which has allowed us to reconsider appropriate mitigations. Both professionals and

non-professionals can now engage in singing, wind, and brass in line with this guidance. People should continue to socially distance from those they do not live with wherever possible. Venues, performers, and audiences should ensure 2m distancing applies wherever possible. However, these studies have indicated that it is the cumulative aerosol transmission from both those performing in and attending events that is likely to create risk. We are continuing to develop more detailed understanding of how to mitigate this potential aggregate risk, but in that context, organisations should therefore consider: **(edited to the factors relevant to indoor rehearsal)**

- Maintaining social distancing wherever possible. Non-professionals should not engage in activities that may lead to social distancing being compromised.
- Ensuring activity takes place outside wherever possible, including performance
- Limiting the number of performers as far as possible (with non-professionals being restricted by rules on meeting people outside your home, with planned activity needing to be aligned with the guidance under the sub-heading on gatherings in Covid-19 secure venues).
- Limiting the duration of social interaction opportunities i.e. rehearsals or performances as far as possible
- Taking steps to improve ventilation as far as possible and whenever possible, both through the use of mechanical systems and opening windows and doors
- Continue to take the other vital steps outlined in this guidance, including preventing unwell people from attending, maintaining cleanliness, supporting contact tracing and other mitigating measures.

**Can amateur groups start rehearsing and performing again?**

Yes – the [Government's Performing Arts guidance](#) applies to both professionals and non-professionals.

The guidance confirms there are no set limits on the numbers who can be involved in planned non-professional activity taking place outside and/or in a Covid-secure venue, but that organisations must ensure an appropriate COVID-19 risk assessment is carried out and that the number of individuals involved are able to be socially distanced at all times.
